Dear Members,

On the 90th Anniversary of Alpha Sigma Nu, I am delighted to inform you of all that we have to celebrate, and to thank you for contributing to our mission. We have inducted more members, raised more funds, and provided more services to our members in that past year than in our history.

In 1915, **John Danihy, SJ**, charged 11 students "to band together those alumni who most fully understand and appreciate the ideals of a Jesuit education and to impress these ideals upon their fellow men." After giving their solemn pledge to abide by these principles, Father Danihy inducted the first members of Alpha Sigma Nu. This year, 1,733 students at our 32 Jesuit member institutions pledged to carry out the ideals of scholarship, loyalty, and service, making our Society over 58,000 members strong.

Today, we are meeting Father Danihy's challenge. The role of the Society in the new millennium is:

- To encourage students to excel academically, serve their campus and community with distinction, and live loyally to Jesuit ideals
- To address our members' desire to deepen their Ignatian spirituality and to live the ideals of scholarship, loyalty, and service in their personal and professional lives

Our 90th Anniversary sees Alpha Sigma Nu Chapters honoring students who will lead their generation guided by Jesuit ideals. Our Alumni Clubs, now in 13 locations, provide a venue for intelligent conversation and action among our members looking to continue their Ignatian formation. We welcome the new St. Louis and Northeastern Pennsylvania Clubs, and thank those alumni instrumental in their development.

You make this possible by your support of the Sustaining Fund. Celebrate with us by contributing to our Society. In 2004-05, Alpha Sigma Nu members contributed a record \$158,104. We have set a goal of \$175,000 to raise in honor of this milestone. Please look for your winter newsletter and 90th Anniversary Sustaining Fund mailing for more information and ways of giving.

At AΣN's 50th Anniversary Dinner, **Pedro Arrupe, SJ**, (Marquette '67) challenged Alpha Sigma Nu members to emphasize scholarship, loyalty, and service after graduation and to "reflect in your works and your words the light of the Gospel." Let us continue to meet this challenge...on to our 100th!

In the past 90 years, much has changed as Alpha Sigma Nu has grown and responded to its members and the times in which we live. The AΣN commitment to scholarship, loyalty to Jesuit ideals, and service to campus and community guides our mission.

The Society has survived two World Wars, the Depression, the '60s and '70s (when some Chapters suspended activities due to campus upheaval), and the global changes leading to the new millennium.

AΣN's health and vitality are in part due to the merging of Alpha Sigma Nu with Gamma Pi Epsilon in 1973. While their coming together was not without its challenges, the mutual purposes, members' dedication to the long-term goals of AΣN, and the strong leadership of both societies ensured the merger's success.

Today, Alpha Sigma Nu Chapters, Clubs, and members act in the spirit of Pedro Arrupe, SJ's challenge to emphasize scholarship, loyalty, and service after graduation and to "reflect in your works and your words the light of the Gospel." We have moved from "being" an honor society to "acting" as a Jesuit honor society:

- Our 32 Chapters honor the Jesuit-trained leaders of tomorrow, encouraging and rewarding their scholarship, loyalty, and service
- Members of these Chapters perform service to their campuses, and to those in need in their communities
- Our 13 Alumni Clubs provide "ongoing formation" of Ignatian spirituality, perform service to their communities, and act as a venue for conversation on living the Jesuit ideals in the new millennium
- Alpha Sigma Nu sponsors scholarships at our 32 member institutions
- In collaboration with the Association of Jesuit Colleges and Universities, AΣN honors authors on our campuses with the Jesuit Book Awards

1915 June 4
John Danihy, SJ, held the first ritual initiation of eleven undergraduate men of Marquette University and inaugurated the Alpha Sigma Tau Honor Fraternity.

1925 The first convention of AΣN held at Marquette. Board of Directors was elected, the constitution passed. Faculty representatives at each campus were to be appointed by the university president, and were members of the Society of Jesus.

April 6 The first initiation ceremony of Gamma Pi Epsilon at Marquette.

1927 The first AΣN Alumni Club was formed in Milwaukee.

1932 The name of the Society was changed to its current title of Alpha Sigma Nu.

1940 The 1940 Convention marked the Society's 25th anniversary.

1947 Gamma Pi Epsilon became a national organization when St. Louis University chartered a Chapter on campus.

1949 The first national Gamma Pi Epsilon convention was held in St. Louis.

MEN AND WOMEN FOR OTHERS ... EVERY DAY

At Wheeling Jesuit, membership in Alpha Sigma Nu means rolling up your sleeves to feed the hungry. Every day...weekends, the day before a paper is due, exam weeks, Christmas break, summers. "Alpha Sigma Nu members take this tradition of service seriously," says **Nicole Meyer** (WJU '04), president of the Wheeling Chapter. "People wouldn't eat without this project!"

WJU Faculty Adviser **Mike Steltenkamp, SJ**, (WJU '95) is the author of this endeavor. In 2001, Father Mike was in the office of former student **Richard Riesbeck** (WJU '03), president and CEO of Riesbeck Foods Inc., when he asked Richard if AΣN students could pick-up leftover bread and deli items from his Wheeling store for delivery to Catholic Charities. Richard readily agreed, "The challenge is the logistics, not the desire to share." Today, Alpha Sigma Nu members facilitate the daily pick-up of food from two Riesbeck stores, as well as delivery of that food to the Wheeling's Catholic Neighborhood Center. "We have 20 current members who commit to volunteer once a week for a pick-up and delivery," says Nicole. "Students know when they receive the honor of induction into Alpha Sigma Nu that this service is an expectation."

The Catholic Charities Neighborhood Center provides food, clothing, utility assistance, health care, and other necessities for the poor, the homeless, and low-income families in the Upper Ohio Valley. Center Director Sr. Constance Dodd, S.M., sees profound changes in both the students and the Center due to the involvement of WJU students. "You cannot rub shoulders with the poor without changing," she comments. "Students truly mature due to their experiences here. From the Center's perspective, we could not do what we do without the students who pick-up, deliver and serve the food. Wheeling Jesuit students help in every aspect of life at the Center." The Center serves more than 100,000 meals a year.

The AΣN Chapter recruits and coordinates other campus volunteers for the program. "Our men's basketball coach and athletic director, **Jay DeFruscio**, is a 'man for others,'" says Father Mike. "He took to the teams the proposition of joining with AΣN, and they agreed to rotate doing pick-ups on certain days of the month. This not only helped AΣN, but it enabled

the athletic community to put another face on their presence to the school and community. Hence AΣN is a yeast for others to do service." Students living at the Mother Jones House, an intentional Christian community of WJU students, do Saturday pick-ups. "We collaborate with 10 agencies on food pick-ups, and the WJU run goes the smoothest," adds Richard. "There are times the Jesuits pitch in; I have seen Father Hacala making the run!" **Joseph Hacala, SJ**, (Loyola Chicago '97) is president of Wheeling Jesuit. Nicole sums up the success of the program, "I have never had a problem getting volunteers. We realize how many people are fed, and appreciate the generosity of Riesbeck's."

After receiving a certificate in accounting in 1969, Richard pursued a bachelor's degree. That pursuit was interrupted by the deaths of his grandmother and parents, and he returned to the family business, Riesbeck's. Founded in 1926, Riesbeck's today has 13 stores, and sales exceeding \$200 million a year.

While a successful executive, Richard increasingly longed to return to school for his bachelor's and master's degrees. He enrolled part-time at Wheeling Jesuit in 2000, majoring in organizational leadership and development, where he met Father Mike and was inducted into Alpha Sigma Nu. He is now pursuing a master's degree in theology. "Ignatian principles teach us that we must serve others, and when we live these principles together, we become inspired by one another," concludes Richard.

1955 The Omaha Alumni Club inaugurated an annual lecture series featuring a nationally known speaker. The first honorary member of Alpha Sigma Nu, **Konrad Adenauer**, Chancellor of West Germany, was inducted at the Creighton Alumni lecture series.

1962 The convention approved the appointment of lay persons as Faculty Advisers.

1964 **Richard H. Trame, SJ** (LMU '62): "Certainly to maintain the fraternity on the basis of strictly male orientation seems to be out of line with general trends in the U.S."
